## **CIDA MEMBERSHIP MEETING MINUTES**

**May 10, 2010**

President Chester brought the meeting to order. Introductions were made around the room. The Minutes were approved as read and the Treasurer's report was read. As of April 10, 2010 we have total in bank and petty cash \$12, 230.32. This was approved as well. Maria Moore also announced that if any of your weeds need to be sprayed to email her.

Jim McNair made an announcement that the American Royal had a good show this past weekend. He also announced other future events and if your business wants to advertise in any of these events to let him know. Tom Roberts made a motion to write a letter to the city about American Royal hosting more agriculture events. The motion passed.

Judi Wright made an announcement regarding her business, Judi's Bakery. They can provide box lunches and breakfast trays for any of your events.

Sg. Schriever spoke on the clean up. They have had three to four pickups with 131 bags of trash collected. Still making contact with the EPA on the tire problem we are still having in the West Bottoms. The police department has also caught two major graffiti markers on Broadway and have linked them to the Bottoms. Please contact the police if you see an A or an A with a circle around it.

Tom Roberts spoke on the email he received from the Sgt. in charge of traffic regarding the bottom of 12th Street and around the corner and at the end of the bridge. The city proposed a no parking and start towing rule or a community sponsored solution. So Roberts spoke with the Retail Group about it. Everyone should be able to make some compromises:

1. The issue is can't get around - parallel parking a must

2. Retail Group has great intent but needs to implement a plan. Maria Moore came up with a good idea of turning 12th St. from East to West as a one way St and Liberty a one way and so on 11th you can nose park. Tom called Greg at the city to do a study on this and to take care of the pot holes as well. There would be no exits then out onto 12th St.

Darby Trotter spoke on the Phase 1 water development and the city has received a million to start construction with on 7th St. to 9th St and then all the way to 670 on Mulberry.

Scott Brown gave an update on the PIAC. Notice is out on the URD project and some issues on tax abatement is still being discussed. PIAC is giving 75,000 for road improvements and 150,000, up to 250,000 for sidewalks and curbs for the 2009, 2010 years.
